




Faculty Review of Open eTextbooks



- This is an anthology of essays on institutional critique, largely in the context of contemporary art. As such, it is not a textbook, and would cover only a small sliver of the Survey's material.
- The included essays are heavily theoretical and presuppose familiarity with, for example, poststructuralist thought and terminology. The essays are not peer reviewed.
- The anthology does not include any illustrations, which would make its use in an introductory survey course challenging.

- As an anthology of scholarly essays rather than a textbook, this book is not designed with teaching or learning outcomes in mind. For instance, it does not include illustrations or a glossary. Some of the essays could potentially be appropriate for an upper-level undergraduate seminar, but not for an entry-level survey.
